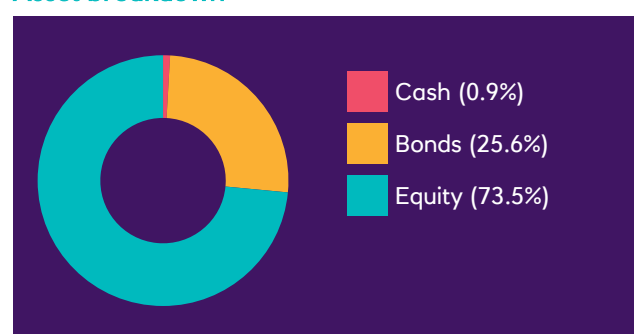
Investment objective

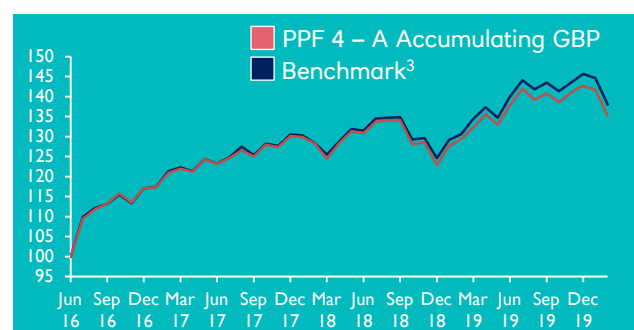

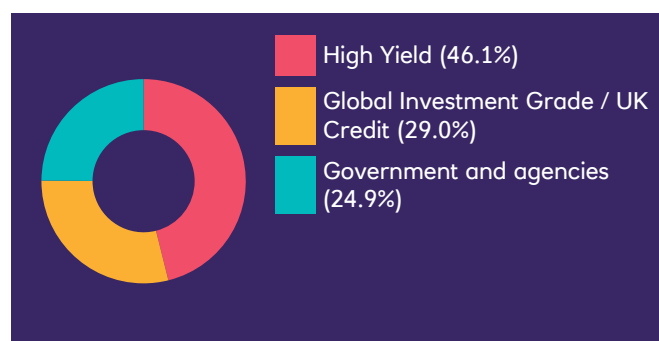

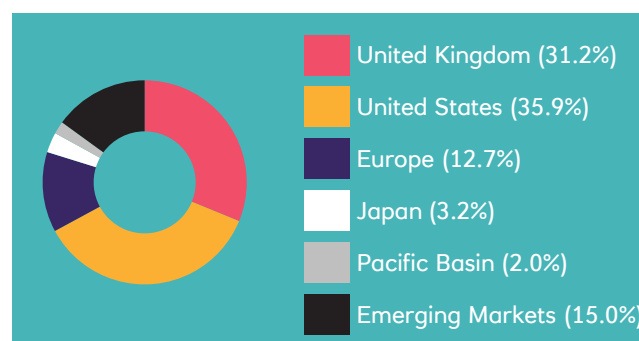
